**February 1, 2026**

**Catholic Health Services offers Financial Assistance to those patients and their families who qualify based upon the most recent Federal Poverty Guideline (FPG) sliding scale, which is based on family size and annual household income.**

**For example, a family of four (4) with a household income of \$66,000 or less (200% of the FPG) would be eligible for free medical care, rent/tuition.**
